TRANSCRIPT OF HEARING

MR. MACEY: The next case on the docket is Case 956.

RANDALL MONTGOMERY,

called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. GURLEY:

- Q State your name, please.
- A Randall Montgomery.
- Q What is your position?
- Geologist, New Mexico Oil Conservation Commission.

- Q Have you had the opportunity to make a study of the proposed extension of the Eumont Pool boundary in Lea County, New Mexico?
 - A Yes, sir, I have.
 - Q Would you state your recommendation and the basis thereon?
- A I recommend that the Eumont boundary be extended as advertised, and also add the southwest quarter of Section 33 Township 21 South, Range 36 East. The reason for the extension of this was occasioned by the changing of the vertical limits according to Order R-520, and the reclassification of several wells, two of the wells producing in Section 33 are the Gulf Arnot-Ramsey D-1 and 2, located in the northwest northwest, and northeast northeas', respective. They are producing oil from the Queen Formation, herefore, requiring the deletion of the Jalmat from this area, that being the north half of Section 33 in the southwest quarter of Section 36.

MR. PORTER: Just one question, Mr. Montgomery. What was the area in, Township 19 South, Range 36 --

- A This is 21 South, Range 36 East.
- Q Have you, Mr. Montgomery, had the opportunity to study the proposed deletion of certain areas from the boundary of the Jalmat Pool?

A Yes, we propose to delete the same area as was mentioned in Section (a), and the reason for that being, the vertical limits of the Jalmat Pool would not enable the operator, Gulf Oil Corporation to drill a gas well in this area, so, therefore, by deleting the Jalmat Pool and extending the Eumont, this will afford Gulf Oil Corporation opportunity to develop their acreage.

MR. MACEY: Let me make sure I understand what you did. You extended the Eumont to take in the north half of the southwest

A Yes.

MR. MACEY: Then you deleted the north half and the southwest quarter?

A Yes.

MR. MACEY: From the Jalmat?

A Yes.

Q Have you, in your official capacity, had an opportunity to study the proposed extension of the Jalmat Pool boundary in Lea County, New Mexico?

- A Yes.
- Q Would you state your recommendations and basis thereon?
- A The reasons for the extension of the Jalmat as advertised, is to take care of those wells which were previously carried in the Cooper-Jal Oil Pool, but due to the change in the vertical limit, as set out in Order R-520, there were numerous wells that would be undesignated and fall in to areas which do not cover the horizontal limits of the Jalmat Pool. Those wells fall within the vertical limits, but were outside the horizontal limits. That is the occasion for the extension of those pools as advertised.
- Q Have you, in your official capacity, Mr. Montgomery, had the opportunity to study the proposed extension of the Langlie-Mattix Pool boundary in Lea County, New Mexico?

A Yes, sir. The extension of the Langlie-Mattix, I recommend it adopted as advertised with the exception, I want to add the west half of Section 30 in Township 25 South, Range 38 East. All these extensions except that in the west half of Section 30-25-38 were brought on by abolishment of the Cooper-Jal Oil Pool. There were 147 wells in the Cooper-Jal Oil Pool, scattered throughout the

trend for a distance of 12 miles. After reclassifying there were only 17, so, for ease of administration it was felt we should abolish the Cooper-Jal and extend the Langlie-Mattix. That would ease our paper work considerably. That extension in the west half of Section 30 was brought on by the completion of the Skelly Hobbs A and the Stanolind State AJ Number 1.

Q Have you anything further to say in regard to proposed abolishment of the Eaves and Cooper-Jal Pools?

A I recommend the abolishment of the Eaves and Cooper-Jal. The Eaves because there are no more wells, after Order R-520 was written, remaining in the Eaves Pool, and recommend the abolishment of the Cooper-Jal for the reason stated previously.

(Marked Commission's Exhibit No. 1, for identification.)

Q Do you have an exhibit?

A Yes, sir, I do. I have an exhibit here, the red line indicates the boundary of the Jalmat, the solid red indicates the additions to the Jalmat and the solid purple indicates the deletion from the Jalmat and the extension of the Eumont. The purple line indicates the Eaves that is to be abolished. The brown line is the Langlie-Mattix and the solid brown is the extensions to the Langlie-Mattix.

MR. GURLEY: I would like to submit this as Exhibit Number 1 MR. MACEY: Without objection it will be received.

CROSS EXAMINATION

By MR. NUTTER:

Q Have you got the code for the colors on the plat?

A Yes.

 - Q (d) is as advertised?
 - A Correct.

MR. MACEY: Anyone else have a question of the witness? If nothing further we will take the case under advisement.

NOW, on this 13th day of October, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

- That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- 2.
