#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on Harch 13, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 25th day of March, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises.

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of gas from the Fruitland formation, said pool to bear the designation Kutz-Fruitland Pool. Said Kutz-Fruitland Pool was discovered by R & G Drilling Company Schlosser Well No. 25, located in the NW/4 SE/4 Section 27, Township 28 North, Range 11 West, NMPM. It was completed August 30, 1956. The top of the perforations is at 1330 feet.


