





MR. UTZ: Case 3111.

MR. DURRETT: Application of Cities Service Oil Company for the expansion of a waterflood project, Chaves County, New Mexico.

MR. KELLAHIN: Jason Kellahin, Kellahin and Fox, Santa Fe, representing the Applicant. We have one witness to be sworn.

(Witness sworn.)

(Whereupon, Applicant's Exhibits 1 2 & 3 marked for identification.)

E. F. MOTTER, called as a witness, having been first duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

BY MR. KELLAHIN:

- Q Would you state your name, please?
- A E. F. Motter.
- Q By whom are you employed and what position?
- A Cities Service Oil Company, Division Engineer of the Texas-Mexico Division.
- Q Have you testified before the Oil Conservation Commission and made your qualifications a matter of record?

A Yes.

MR. KELLAHIN: Are the witness' qualifications acceptable?

MR. UTZ. Yes, sir, they are.

- Q Are you familiar with the application of Cities . Service in Case 3111?
 - A Yes, I am.
- Q Would you state briefly what Cities Service proposes in this application?
- A Tract 46, which is the north half of the northeast quarter of Section 22 --
 - Q Is that shown on Exhibit Number 1?
- A Yes, excuse me, on Exhibit 1, will come into this unit effective tomorrow. This is a tract that has been in our unit since '59 and we finally negotiated it into the unit. This lease originally had two wells drilled on it. The Number 2 Well was plugged and abandoned in 1959. The Number 1 Well has been an exceptionally good well of an accumulated 125,831 barrels of oil. The Number 2 had produced in excess of 26,000 barrels prior to its abandonment.

As you will note from Exhibit Number 1, that if we followed the same pattern which was established in this field some five or six miles north of here where the floods were first started, that the Tract 46 Well Number 1 would be an injection well. We think that it would be a loss of production to make this an injection well and force this oil into other areas, perhaps down into the area 46, to where some of it might be lost. So, we plan to leave it as a producing well and convert Wells 9 - 1,



and 9 - 2. In the light blue pencil, Tract 1 Well Six and Tract 9, Well 2 were approved for injection administratively on September 18, 1964. The two red wells are the subject wells; the green circled well, which is labeled the O'Neil Number 4, is in the Continental operated East Caprock Unit. It is not an injection well at this time. Continental has had difficulty in securing all the approvals to put the Shelton and Warren Lease, which is immediately east of that, into the unit. However, they advise us that as soon as this is arranged they will put this well on injection.

As you will note, this is a change of pattern from what we have established in the north. However, this is a continuation of a pattern that was established by the Union Flood immediately south of the Continental East Caprock Unit. So, we have chosen to put on the two injection wells, or ask that they be put on, first, so that we may drive the oil away from the old abandoned Well Number 2, and secondly, we feel there will be more ultimately leaving Number 1 on production.

- Q Referring to what has been marked as Exhibit 2, explain that.
- A These two exhibits are schematics of the wells themselves, indicating the surface pipe, the amount of cement used, the open hole completion, the point at which we will set tubing along with tension anchor.



- Q Will that completion adequately protect any producing horizons or fresh water zones encountered?
 - A Yes, we think it will.
- Q Mr. Motter, has the area in Tract Number 46 received a response from the waterflood?
 - A No, sir.
- Q And that is the reason you require approval at this time of the injection wells?
- A Yes, if you'll note, our closest injection well is Tract

 2 Well Number 1, which is the northwest-southwest of Section 15.

 We have purposely stayed away from this tract as long as

 possible with our flood until it was negotiated into the unit.
- Q In your opinion is the approval of Cities Service in the interest of conservation and protection of correlative rights?
 - A Yes.
- Q Were Exhibits 1 through 3 prepared by you or under your supervision?
 - A Yes, they were.

MR. KELLAHIN: I would like to offer in evidence Exhibits 1, 2 and 3.

MR. UTZ: Without objection the Exhibits 1, 2 and 3 will be entered into the record of this case.

(Whereupon, Applicant's Exhibits 1, 2 & 3 were admitted in evidence.)

CROSS EXAMINATION

BY MR. UTZ:

- Referring to your Exhibit Number 1 again, what did you say the wells circled in blue indicated?
- Those are proposed injection wells which we have received administrative approval on September 18th to convert. Those were through the response of Tract 2, Well 2; therefore, they come under the administrative procedure.
- Number 9 Wells, the two wells are covered in Exhibits 2 and 3 that you have requested at this time?
- Tract 9, Well Number 1 and Tract 46, Well 2; they are the wells circled in red.
- Is this completion that you recommend here on your Exhibits 2 and 3 identical to the completions used in the balance of your flood?
- Yes, they are. I guess I would like to point out one thing. It is on the exhibit, the tubing is cement lined to protect against corrosion.
 - You fill the annulus with inert fluid?
- Normally we fill it with fresh water and it soon becomes neutral.

MR. UTZ: Are there any other questions of the witness? REDIRECT EXAMINATION

BY MR. KELLAHIN:



Have you received administrative approval from the Oil Conservation Commission of the inclusion of this tract as provided by Order R-1477?

Yes, we have. On September 24th, Administrative Order UX-4 administratively approves the enlargement of the Drickey Queen Unit to include the west half-northwest quarter Section 22 Township 14 South, Range 31 East, Chaves County. We have received also approval from the New Mexico Land Office, and we have filed everything with the United States Geological Survey, assuming that this will be approved.

MR. UTZ: The description of both these tracts have been approved administratively?
