ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9:00 a.m. on March 23, 1977, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this <u>26th</u> day of April, 1977, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of East Burton Flat-Atoka Gas Pool. Said East Burton Flat-Atoka Gas Pool was discovered by the J. C. Williamson and D. W. Underwood et al Williamson Federal Well No. 1 located in Unit J of Section 9, Township 20 South, Range 29 East, NMPM. It was completed in the Atoka formation on October 15, 1976. The top of the perforations is at 10,927 feet.

(3) That there is need for the creation of a new gas pool in Lea County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of North Eidson-Morrow Gas Pool. (12) That there is need for certain extensions to the Cemetery-Morrow Gas Pool, the North Dagger Draw-Upper Pennsylvanian Pool, the South Empire-Morrow Gas Pool, the Indian Draw-Delaware Pool, the South Loco Hills-Morrow Gas Pool, the Red Lake Queen - Grayburg - San Andres Pool, and the White City-Pennsylvanian Gas Pool, all in Eddy County, New Mexico, and the Baum-Upper Pennsylvanian Pool, the South Bell Lake-Atoka Gas Pool, the South Bell Lake-Morrow Gas Pool, the Blinebry Oil and Gas Pool, the North Teague-Devonian Gas Pool, the North Vacuum-Abo Pool, and the Warren-Tubb Gas Pool, all in Lea County, New Mexico.

IT IS FURTHER ORDERED:

(1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a nonstandard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations and extensions included herein shall be May 1, 1977.

(1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool.
