To Whom It May Concern,

ConocoPhillips Company is requesting a six (6) month extension to the determination of cessation of operations for the Zia Hills Recycling Facility and Containment (Permit/Registration #1RF-454).

Per 19.15.34.13 C. A recycling containment shall be deemed to have ceased operations if less than 20% of the total fluid capacity is used every six months following the first withdrawal of produced water for use. The operator must report cessation of operations to the appropriate division district office. The appropriate division district office may grant an extension to this determination of cessation of operations not to exceed six months.

Based on the definition of less than 20% of the total fluids capacity being used every six months, unless produced water is treated in June 2021 the operations at the Zia Hills Recycling Facility and Containment would be deemed to have ceased on 6/30/2021.

Due to the impacts of COVID19 on drilling and completions events it is doubtful that greater than 20% of the total fluids capacity will be used by June 30, 2021, as such a 6 month extension is requested until 12/31/2021.
