Hello Cory,

Enduring Resources has contracted EIS to assist in permitting Recycling Containments for two AST's (Aboveground Surface Tanks) at two different locations. The two locations have already had Recycling Facilities and Recycling Containments permitted at them in the past by Enduring, but these containments have since ceased operations and been closed. The two locations are Enduring's WEU 300H (NMOCD Permit #3RF-42) and Rodeo Unit 511H (NMOCD Permit #3RF-44). Presently, they would like to set (1) 60,000 bbl. AST and (1) 50,000 bbl. AST on the WEU 300H and then move the same two tanks to the Rodeo Unit 511H. My question for you is how best to "re-permit" these containments with you. Would you prefer we apply for all new permits at the same locations? Or would we file an extension for the old permits? Enduring will be using the same tanks and operation as they use before.
