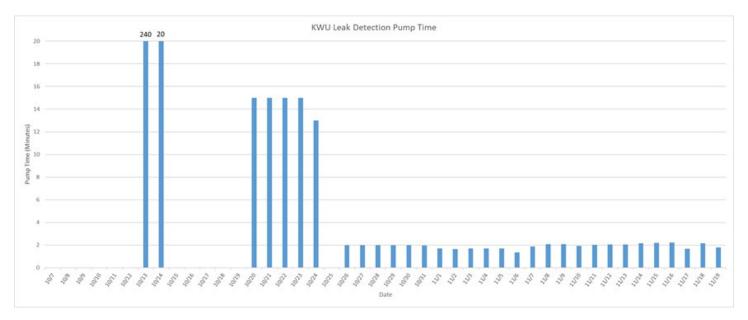

# **Enduring Resources KWU 2309-19K 3RF-43 Primary Liner Compromise Repair Report**

Enduring reached the 70% incremental volume at KWU 2309-19K 3RF-43 on 11/18/2021. Enduring commenced the 24-hour test on 11/19/2021. After 24 hours, with the continuation of similar leak detection pump times and similar water quality, the data indicates small amounts of water continue to migrate to the leak detection system as filling operations continue. We also continue to observe ice buildup between the two pond layers. This is likely caused by condensation being created during the day and freezing at night; therefore, we are likely to continue to see some liquid migration throughout the pond fill. Enduring Resources concludes that the primary liner continues to be leak free and filling operations have commenced to the next 10% milestone.
