Joe,

I appreciate the feedback. We've recently completed the C145 to transfer existing AGI wells from Lucid OGRID to Targa OGRID but when running a facility search under the Targa OGRID 331548 no facilities were listed. I did check the NMOCD Industry Oversight page for Oil and Gas however there are no specific instructions related to facility creation or registration. In the past I've seen facility IDs that represent wells, compressor stations, and even closure approved remediation sites but I've never "registered a facility" so I'm unfamiliar with the process.

Can you please explain how these facility IDs are created? Would the Natural Gas Gathering Systems (NGGS) required for venting and flaring reporting be transferred as part of a C145? Does Targa need to register a new NGGS as part of NMAC 19.15.28? If so, would a NGGS registration create a facility ID?

The ID # is non-transferable you would need to register as new operator. If you are transferring wells from one operator to another you can file a C-145. If the company is staying the same but under a new name, you can file a C-146 but it's like registering as a new operator.
