To whom it may concern,

Thank you for allowing Steward Energy to promote water recycling and subsequent use of recycled produced water for Oil & Gas operations in the State of New Mexico. The objective of this letter is to notify the NMOCD of a primary liner breach in the Llano Estacado Reuse Pit.

At approximately 3:40 pm on 11/14/2023, the leak detection system was run at the Llano Estacado Reuse Pit, NMOCD Permit # 1RF-506. Upon performing our weekly leak detection test, facility operators notified the supervisor that water was present and pumping approximately 16 GPM.

The leak detection test last ran on 11/07/2023 when the pit level was below 6 feet and zero flow was detected. Between the dates of 11/07/2023 and 11/14/2023, the pit level rose to 10 feet in preparation for an upcoming frac to which this water is dedicated. We are confident that the primary liner breach is somewhere between the water level depth of 6 to 10 feet.

We are currently draining the pit, monitoring & inspecting every foot of depth that volume goes down. We plan to start pulling the pit level down by end of day 11/16/2023.

Steward Energy would like to propose continuing to run the leak detection pump to reduce the volume of water between the primary and secondary liners. Once pit operations commence, the facility operators will inspect the pit liner at each foot of depth reduced. A comprehensive report with details and pictures of the Root Cause will be provided to the NMOCD with corrective actions to be implemented.
