Dear Mr. Dimond:

On April 23, 2023, the Oil Conservation Division (OCD) received a closure notice for Permit NM2-004 via email from Animas Environmental Services, LLC (AES). This notice informed the OCD of the following: "In accordance with the January 2024 Closure/Post-Closure Plan, BMG plans to begin reclamation of landfarm cells 1 through 4 on Tuesday, April 30, 2024."

The OCD is informing Benson-Montin-Greer Drilling Corp (BMG) that closure activities cannot be conducted on April 30, 2024. This proposed date does not meet regulatory guidelines. 19.15.36.18.A(1) NMAC states, "The operator shall notify the division's environmental bureau at least 60 days prior to cessation of operations at the surface waste management facility and provide a proposed schedule for closure. Upon receipt of such notice and proposed schedule, the division shall review the current closure and post closure plan (post closure is not required for oil treating plants) for adequacy and inspect the surface waste management facility."

In Section 1 of the January 2024 Closure/Post-Closure Plan, BMG provides the following response: "Submittal of this Closure Plan and Landfarm Exception Request is also intended to serve as notification to NMOCD that BMG intends to close the landfarm cells on March 25, 2024, which is in accordance with the closure notification requirement in New Mexico Administrative Code (NMAC) 19.15.36.18.A.1."

Pursuant to 19.15.36.18.A(2) NMAC, "*The division shall notify the operator within 60 days after the date of cessation of operations specified in the operator's closure notice of modifications of*

the closure and post closure plan and proposed schedule or additional requirements that it determines are necessary for the protection of fresh water, public health or the environment.” Based upon BMG’s response to 19.15.36.18.A(1) NMAC, OCD’s 60-day review period began on March 25, 2024, which means OCD has until May 24, 2024, to complete the review.


Upon OCD’s initial review of the January 2024 Closure/Post-Closure Plan, the OCD identified multiple exception requests that were not formally requested in the proposed plan. For example, some of the exception requests identified that were not specifically requested by BMG are as follows:

- BMG proposes to use historical sampling data rather than performing the treatment zone closure sampling as required by 19.15.36.15.F NMAC and 19.15.36.18.C(4)(a-d) NMAC; and
- BMG proposed to use Form C-137 EZ which is only applicable for an OCD small registered landfarm pursuant to 19.15.36.16 NMAC.

For good cause, 19.15.36.18.A(3) NMAC allows the director to extend OCD’s review of the current closure and post closure plan for an additional period not to exceed 60-days. Due to multiple exception requests identified in the January 2024 Closure/Post-Closure Plan, I hereby approve an additional 60 days to complete OCD’s review and as such the OCD has until July 23, 2024, to complete their review of the January 2024 Closure/Post-Closure Plan.


