





NMOCD has reviewed the permit/registration transfer application received from [372338] NGL WATER SOLUTIONS PERMIAN, LLC on 01/28/2025, Application ID 425815, to transfer permit 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220] from [372338] NGL WATER SOLUTIONS PERMIAN, LLC to [332820] Hydrosorce Logistics Waste Management, LLC. The form C-147 and related documents are approved for the transfer of permit/registration with the following conditions of approval:

- **[332820] HYDROSOURCE LOGISTICS WASTE MANAGEMENT, LLC will comply with all conditions previously approved for permit 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220]. No changes to the operations procedures, maintenance, and monitoring procedures, or closing procedures will be made and 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220] must operate as originally permitted.**
- 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220] permit expires on June 14, 2025.
- A minimum of 3-feet freeboard must be maintained at 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220] at all times during operations.
- If less than 20% of the total fluid capacity is utilized every six months, beginning from the first withdrawal, operations of the 1RF-443 - MCCLOY WEST RECYCLING FACILITY [fBGB1924149220] are considered ceased and a notification of cessation of operations should be sent electronically to OCD Permitting. A request to extend the cessation of operations, not to exceed six months, may be submitted using a C-147 form through OCD Permitting.
