Dear Ms. Hartson,

The NM OCD has reviewed and hereby approves the 2024 Annual Report, with Closure Cost Estimates, for Milestone Environmental Services, LLC (OGRID No. 328435)- Baeza SWD Commercial Waste Management Facility (Permit No. NM1-64). An approval email will also be sent to you by the OCD online permitting system.

The OCD is in receipt of a new surety bond numbered SURU2210006086 (not yet approved) and a request to release the present surety bond and bond rider numbered SUR0074995. Please submit a new surety instrument in the amount of \$406,017, which is the updated Closure Cost Estimate provided in the 2024 Annual Report. After we receive and upon approval of the new surety bond, we will send a letter of release for the other two bonds.

Furthermore, the revised permit NM1-64 issued April 24, 2024 states in condition 6(L): "The operator must provide the OCD with a finalized contingency plan required by 19.15.36.13 NMAC by September 1st 2024." OCD cannot locate such contingency plan in our record. A finalized contingency plan must be submitted to the OCD, within 45 days of receipt of this email, through OCD's Permitting portal at <https://wwwapps.emnrd.nm.gov/OCD/OCDPermitting/default.aspx>, for OCD's review and consideration of approval.
