The OCD has rejected the submitted *Application for administrative approval of a release notification and corrective action* (C-141), for incident ID (n#) nAPP2400362480, for the following reasons:

- Remediation closure report is denied for the following reasons: 1. It is noted in the report that figures 2, 4, and 5 are scaled diagrams, however, Figure 3 "Confirmation Sample and Excavation Depth Map" is missing the scale. Include the scale for Figure 3 in the next submittal. 2. In Section 3 of the Report, "Soil Confirmation Sampling and Analytical Results," the report states confirmation samples were collected "when necessary, along the side walls." Clearly show the location of all side wall samples in the next report. 4. As stated in the conditional approval of the Remediation Plan, SP9 and SP10 must be addressed. It is indicated in the Closure Report that these two sample points go with Incident # nAPP2233947666. (Note: The Report states APP ID 163890 which is for the NOR. Remediation Closure Report is APP ID 314992). Incident nAPP2233947666 was approved for remediation closure on 4/17/24.
- A review of that report shows no chloride levels of the magnitude of SP9 and SP10 were reported. Incident nAPP2233947666 is north of the current Incident and does

not appear to have affected the area around SP9 and SP10. 5. Select Energy Services shall complete the remediation of the remaining contamination within 90 days. A final report documenting the successful completion of these remedial actions must be received by the OCD by 11/24/2025.

The rejected C-141 can be found in the OCD Online: Permitting - Action Status, under the Application ID: 457730.
