ORDER NO. AG-CD-1

SUPPLEMENTARY GAS PRORATION ORDER FOR THE MONTH
OF APRIL, 1957

The Commission held public hearing at Santa Fe, New Mexico, on March 14, 1957, at 9 o'clock a.m., pursuant to legal notice, for the purpose of setting the allowable production of gas from the Crosby-Devonian Gas Pool in Lea County, New Mexico, for the month of April, 1957.

NOW, on this day the Commission, a quorum being present, having considered the supplementary nominations of purchasers, the capacity of producing wells, and being otherwise fully advised in the premises,

FINDS:

(1) The total nominations of purchasers of gas from the Crosby-Devonian Gas Pool for the month of April, 1957, is 480,000 MCF.

(2) The potential producing capacity of all gas wells in the Crosby-Devonian Gas Pool is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the aforesaid gas pool should be limited, allocated, and distributed during the month of April, 1957.

(3) That all the producing gas wells together with the expected completed or recompleted wells in the Crosby-Devonian Gas Pool can produce a total of 480,000 MCF without causing waste during the month of April, 1957, and an allocation based upon such production would be reasonable and protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That for the month of April, 1957, the allowable production to be assigned the Crosby-Devonian Gas Pool in Lea County, New Mexico, be and the same hereby is 480,000 MCF.

(2) That the allocation hereby set for the month of April, 1957, in the Crosby-Devonian Gas Pool in Lea County, New Mexico, shall be in accordance with the provisions of Order R-639-A and the Commission's Rules and Regulations.

(3) A proration schedule, duly prepared by the Commission and thereafter adopted for the month of April, 1957, is hereto attached and made a part hereof; it distributes and allocates the allowable production among the gas wells in the Crosby-Devonian Gas Pool for the period stated, in accordance with the Rules and Regulations and Order R-639-A.


The foregoing order shall remain effective until further order of the Commission.
