ORDER NO. AG-N-31-A

SUPPLEMENTARY GAS PRORATION ORDER FOR THE MONTH  
OF AUGUST, 1970

---

The Commission held public hearing at Santa Fe, New Mexico, on July 15, 1970, at 9 a.m., pursuant to legal notice, for the purpose of setting the allowable production of gas from the following nine gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, for the month of August, 1970.

Basin-Dakota, Blanco-Mesaverde, Aztec-Pictured Cliffs, Ballard-Pictured Cliffs, Blanco-Pictured Cliffs, South, Fulcher Kutz-Pictured Cliffs, Kutz-Pictured Cliffs, West, Tapacito-Pictured Cliffs, and Devils Fork-Gallup.

NOW, on this 20th day of July, 1970, the Commission, a quorum being present, having considered the supplementary nominations of purchasers, the capacity of producing wells, and being otherwise fully advised in the premises,

FINDS:

(1) That the total nomination of purchasers of gas produced from the above-listed nine gas pools for the month of August, 1970, is 36,476,127 Mcf. The individual pool nominations are as follows:

Blanco-Mesaverde	15,828,800 Mcf
Aztec-Pictured Cliffs	879,900 Mcf
Ballard-Pictured Cliffs	947,300 Mcf
Blanco-Pictured Cliffs, South	2,533,800 Mcf
Fulcher Kutz-Pictured Cliffs	429,700 Mcf
Kutz-Pictured Cliffs, West	291,100 Mcf
Tapacito-Pictured Cliffs	603,000 Mcf
Devils Fork-Gallup	84,527 Mcf

(2) That the potential producing capacity of all gas wells in the nine gas pools listed above is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the above-listed nine gas pools should be limited, allocated, and distributed during the month of August, 1970.

(3) That all the producing gas wells, together with the expected completed or re-completed wells in the nine gas pools listed above, can produce a total of 36,476,127 Mcf without causing waste during the month of August, 1970, and an allocation based upon such production would be reasonable and would protect correlative rights.

ORDER NO. AG-N-31-A

IT IS THEREFORE ORDERED:

(1) That for the month of August, 1970, the allowable production to be assigned the nine allocated gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, is as follows:

Blanco-Mesaverde	15,828,800 Mcf
Aztec-Pictured Cliffs	879,900 Mcf
Ballard-Pictured Cliffs	947,300 Mcf
Blanco-Pictured Cliffs, South	2,533,800 Mcf
Fulcher Kutz-Pictured Cliffs	429,700 Mcf
Kutz-Pictured Cliffs, West	291,100 Mcf
Tapacito-Pictured Cliffs	603,000 Mcf
Devils Fork-Gallup	84,527 Mcf

(2) That the allocation hereby set for the month of August, 1970, in the nine allocated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, shall be in accordance with the Commission Rules, Regulations, and Orders.

(3) That a proration schedule, duly prepared by the Commission and thereafter adopted for the month of August, 1970, is hereto attached and made a part hereof; it distributes and allocates the allowable production among the gas wells in the nine gas pools listed above for the period stated, in accordance with the Commission Rules, Regulations, and Orders.


The foregoing order shall remain effective until further order of the Commission.
