ORDER NO. AG-N-44-4

SUPPLEMENTAL GAS PRORATION ORDER FOR THE MONTH
OF JULY, 1982

This cause came on for public hearing before the Division's Examiner, Daniel S. Nutter, at Santa Fe, New Mexico, on June 17, 1982, at 9 a.m., pursuant to legal notice for the purpose of setting the allowable production of gas from the following four gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, for the month of July, 1982.

Basin-Dakota, Blanco-Mesaverde, Blanco-Pictured Cliffs, South, and Tapacito-Pictured Cliffs.

NOW, on this 18th day of June, 1982, the Division Director, having considered the supplemental nominations of purchasers, the capacity of producing wells, and the recommendations of the Examiner, and being otherwise fully advised in the premises,

FINDS:

(1) That the total nomination of purchasers of gas produced from the above-listed four gas pools for the month of July, 1982, is 33,927,361 Mcf. The individual pool nominations are as follows:

Basin-Dakota	12,539,161 Mcf
Blanco-Mesaverde	19,349,100 Mcf
Blanco-Pictured Cliffs, South	1,611,300 Mcf
Tapacito-Pictured Cliffs	427,800 Mcf

(2) That the potential producing capacity of all gas wells in the four gas pools listed above is in excess of the nominations of purchasers of gas, and in order to prevent waste and protect correlative rights, the production of gas from the above-listed four gas pools should be limited, allocated, and distributed during the month of July, 1982.

(3) That all the producing gas wells, together with the expected completed or recompleted wells in the four gas pools listed above, can produce a total of 33,927,361 Mcf without causing waste during the month of July, 1982, and an allocation based upon such production would be reasonable and would protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That for the month of July, 1982, the allowable production to be assigned the four allocated gas pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, is as follows:

Basin-Dakota	12,539,161 Mcf
Blanco-Mesaverde	19,349,100 Mcf
Blanco-Pictured Cliffs, South	1,611,300 Mcf
Tapacito-Pictured Cliffs	427,800 Mcf


(2) That the allocation hereby set for the month of July, 1982, in the four allocated pools in San Juan, Rio Arriba, and Sandoval Counties, New Mexico, shall be in accordance with the Division Rules, Regulations, and Orders.

(3) That a proration schedule, duly prepared by the Division and thereafter adopted for the month of July, 1982, is hereto attached and made a part hereof; it distributes and allocates the allowable production among the gas wells in the four gas pools listed above for the period stated, in accordance with the Division Rules, Regulations, and Orders.

The foregoing order shall remain effective until further order of the Division.
