COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 18, 1965, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 18th day of August, 1965, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Wolfcamp formation, said pool to bear the designation of Burtner-Wolfcamp Pool. Said Burtner-Wolfcamp Pool was discovered by Standard Oil Company of Texas, State 22 No. 1, located in Unit H of Section 22, Township 15 South, Range 33 East, NMPM. It was completed in Wolfcamp on May 18, 1965. The top of perforations is 9722 feet.

(3) That there is need for the creation of a new pool in Roosevelt County, New Mexico, for the production of oil from the Abo formation, said pool to bear the designation of Milnesand-Abo Pool. Said Milnesand-Abo Pool was discovered by J. C. Williamson, Mobil Federal No. 2, located in Unit A of Section 33, Township 8 South, Range 35 East, NMPM. It was completed in Abo on May 17, 1965. The top of perforations is 8880 feet.

(4) That there is need for the consolidation of the South Lane-Pennsylvanian Pool and the Inbe-Pennsylvanian Pool in Lea County, New Mexico, inasmuch as both pools produce from the same formation.

Said consolidation to be accomplished by the abolishment of the South Lane-Pennsylvanian Pool and extension of the Inbe-Pennsylvanian Pool.

(5) That there is need for certain extensions to the Indian Basin-Upper Pennsylvanian Gas Pool in Eddy County, New Mexico, the North Bagley-Middle Pennsylvanian Pool, the Blinebry Oil Pool, the Flying "M"-San Andres Pool, the Justis-Blinebry Pool, the Lusk-Strawn Pool, the Mescalero-San Andres Pool, the Morton-Lower Wolfcamp Pool, the Osudo-Wolfcamp Pool, the Pearl-Queen Pool, and the Wilson-Pennsylvanian Gas Pool, all in Lea County, New Mexico, and the Todd-San Andres Gas Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Wolfcamp production, is hereby created and designated as the Burtner-Wolfcamp Pool, consisting of the following described area:

TOWNSHIP 15 SOUTH, RANGE 33 EAST, NMPM
SECTION 22: NE/4

(b) That a new pool in Roosevelt County, New Mexico, classified as an oil pool for Abo production, is hereby created and designated as the Milnesand-Abo Pool, consisting of the following described area:

SECTION 33: NE/4

(c) That the South Lane-Pennsylvanian Pool in Lea County, New Mexico, consisting of the following described area:

TOWNSHIP 10 SOUTH, RANGE 33 EAST, NMPM
SECTION 23: S/2
SECTION 26: S/2, NW/4, and W/2 NE/4
SECTION 27: SE/4
SECTION 34: E/2 and SW/4
SECTION 35: W/2 and NE/4

TOWNSHIP 11 SOUTH, RANGE 34 EAST, NMPM
SECTION 6: All

is hereby abolished.

(d) That the Inbe-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

SECTION 23: S/2

SECTION 27: SE/4
SECTION 34: E/2 and SW/4
