NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 15, 1965, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 16th day of December, 1965, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and subject matter thereof.
- (2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Wolfcamp formation, said pool to bear the designation of Caprock-Wolfcamp Pool. Said Caprock-Wolfcamp Pool was discovered by Petroleum Corporation of Texas, Livermore "G" No. 9, located in Unit C of Section 31, Township 12 South, Range 32 East, NMPM. It was completed in Wolfcamp on September 22, 1965. The top of perforations is 8701 feet.
- (3) That there is need to extend the vertical limits of the Middle Lane-Pennsylvanian Pool to include the Lower portion of the Wolfcamp formation in order to clarify the nomenclature of present producing wells in this reservoir. Further, redesignate said pool as Middle Lane Permo-Pennsylvanian Pool.
- (4) That there is need for certain extensions to the Chaveroo-San Andres Pool in Chaves and Roosevelt Counties, New Mexico, the Baish-

Wolfcamp Pool, the Blinebry Oil Pool, the Drinkard Pool, the Fowler-Blinebry Pool, the Jenkins-Cisco Pool, the East Saunders Permo-Pennsylvanian Pool, the Sawyer-San Andres Gas Pool, and the Stateline-Ellenburger Pool, all in Lea County, New Mexico, and the Bluitt-San Andres Gas Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Wolfcamp production, is hereby created and designated as the Caprock-Wolfcamp Pool, consisting of the following described area:

TOWNSHIP 12 SOUTH, RANGE 32 EAST, NMPM
SECTION 31: NW/4

(b) Extend the vertical limits of the Middle Lane-Pennsylvanian Pool in Lea County, New Mexico, to include the lower portion of the Wolfcamp formation and redesignate said pool as the Middle Lane Permo-Pennsylvanian Pool.

(c) That the Baish-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

SECTION 15: SW/4

(d) That the Blinebry Oil Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(e) That the Bluitt-San Andres Gas Pool in Roosevelt County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(i) That the Jenkins-Cisco Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(j) That the East Saunders Permo-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:




That the effective date of this order and all creations and extensions of vertical and horizontal limits included herein shall be January 1, 1966.
