ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on October 9, 1968,
at Santa Fe, New Mexico, before Examiner Elvis A. Utz.

NOW, on this 22nd day of October, 1968, the Commission, a
quorum being present, having considered the testimony, the record,
and the recommendations of the Examiner, and being fully advised
in the premises,

FINDS:

(1) That due public notice having been given as required by
law, the Commission has jurisdiction of this cause and the subject
matter thereof.

(2) That by Order No. R-3471, dated August 13, 1968, the
Commission approved the Guadalupe Ridge Unit Agreement, at the
request of Sinclair Oil & Gas Company, comprising 23,357.64
acres, more or less, of Federal and Fee lands described as
follows:

EDDY COUNTY, NEW MEXICO

Sections 4 through 6: All

(3) That said Order No. R-3471 was to become effective upon the approval of said unit agreement by the Director of the United States Geological Survey.

(4) That Sinclair Oil Corporation, formerly Sinclair Oil & Gas Company, in order to receive said approval, seeks amendment of said unit agreement to conform to certain requirements of the Director of the United States Geological Survey.

(5) That said amendments are in the interest of good conservation practices and the protection of correlative rights.

(6) That the subject application should be approved.

IT IS THEREFORE ORDERED:

(1) That Order (1) of Order No. R-3471 is hereby amended to read in its entirety as follows:


"(1) That the Guadalupe Ridge Unit Agreement, as amended, is hereby approved."
