ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a. m., on November 19, 1953, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 24th day of November, 1953, the Commission, a quorum being present, having considered the testimony adduced at the hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That extensions should be approved for the Blanco-Mesaverde, South Blanco - Tocito, South Blanco - Dakota, and South Blanco - Pictured Cliffs Pools, in accordance with proper advertisement and the testimony presented at the November 19, 1953, hearing.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and the same hereby is approved, as follows:
