FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the evidence presented in this case indicates that the pools presently designated as the Ballard-Pictured Cliffs Pool, the Canyon Largo-Pictured Cliffs Pool, and the Otero-Pictured Cliffs Pool, as well as the presently undesignated acreage in Rio Arriba County set forth below, are all one common source of supply.

(5) That operators who have drilled wells on non-standard units within the proposed extension, and who have not yet received approval for such non-standard units, should file applications for non-standard proration units in the Ballard-Pictured Cliffs Pool pursuant to the provisions of Order No. R-846 prior to April 15, 1959.

1. That the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby contracted by the deletion of the following described area:
