ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 13, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 13<sup>th</sup> day of December, 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, and the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, the Otero-Pictured Cliffs Pool and the Tapicito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, and the Ballard-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Ballard-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


