ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 16, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 30th day of January, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of oil from the Gallup formation, said pool to bear the designation Verde-Gallup Oil Pool. Said Verde-Gallup Oil Pool was discovered by C. M. Carroll Ute #1, located in the SE/4 SE/4 Section 14, Township 31 North, Range 15 West, NMPM. It was completed September 23, 1955. The depth of the casing shoe is 2,335 feet.

(3) That there is need for certain extensions to the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool, and the West Kutz-Pictured Cliffs Pool, all in San Juan County, New Mexico, and to the Ballard-Pictured Cliffs Pool, the South Blanco-Pictured Cliffs Pool, and the Blanco Mesaverde Pool, all in San Juan and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(i) That a new pool in San Juan County, New Mexico, classified as an oil pool for Gallup production, be and the same is hereby created and designated as the Verde-Gallup Oil Pool, consisting of the following described area:

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 9, 1957, at Santa Fe, New Mexico, before Warren W. Mankin, Examiner duly appointed by the New Mexico Oil Conservation Commission, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 12th day of February, 1957, the Commission, a quorum being present, having considered the application, the evidence adduced and the recommendations of the Examiner, Warren W. Mankin, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That applicant is the owner of an abandoned oil well in the Bough Pool known as its T. Betenbough No. 2, located in the SE/4 SW/4 Section 12, Township 9 South, Range 35 East, NMPM, Lea County, New Mexico.

(3) That applicant proposes to inject salt water through open hole from 9606 feet to 9639 feet into the Bough Lime.

(4) That applicant's proposed salt water injection program will not jeopardize the production of oil or gas or fresh water in the area.

(5) That applicant's proposed salt water injection program is consonant with sound conservation practices.

IT IS THEREFORE ORDERED:

1. That the applicant, Magnolia Petroleum Company, be and the same is hereby authorized to convert its T. Betenbough Well No. 2, located in the SE/4 SW/4 Section 12, Township 9 South,

Range 35 East, NMPM, into a salt water disposal well in the Pennsylvanian formation of the Bough Pool. All salt water will be injected into the Pennsylvanian formation of the Bough Pool through open hole at a depth of 9606 feet to 9639 feet.

2. That applicant shall submit monthly reports of its disposal operations in accordance with Rule 704 and 1119 of the Commission Statewide Rules and Regulations.


