APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING, CONTRACTING VERTICAL AND HORIZONTAL LIMITS, REDESIGNATING AND EXTENDING CERTAIN POOLS IN LEA COUNTY, NEW MEXICO.

### ORDER OF THE DIVISION

#### BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on December 21, 2000 at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 8 the day of February, 2001, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

#### **FINDS THAT:**

- (1) Due public notice has been given and the Division has jurisdiction of this case and its subject matter.
- (2) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the San Andres formation, bearing the designation of Aqueduct-San Andres Pool. The Aqueduct-San Andres Pool was discovered by the Beach Exploration Inc. Laughlin Well No. 1 located in Unit L of Section 19, Township 19 South, Range 38 East, NMPM, which was completed in the San Andres formation on November 30, 1999. The top of the perforations is at 4,248 feet.
- (3) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Delaware formation, bearing the designation of South Bell

Lake-Delaware Pool. The South Bell Lake-Delaware Pool was discovered by the Kaiser Francis Oil Company Bell Lake Well No. 20 located in Unit G of Section 6, Township 24 South, Range 34 East, NMPM, which was completed in the Delaware formation on May 11, 2000. The top of the perforations is at 8,298 feet.

- (4) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the San Andres formation, bearing the designation of Hightower-San Andres Pool. The Hightower-San Andres Pool was discovered by the C.W. Trainer Tower Well No. 2 located in Unit M of Section 23, Township 12 South, Range 33 East, NMPM, which was completed in the San Andres formation on September 16, 2000. The top of the perforations is at 4,288 feet.
- (5) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of North Leamex-Wolfcamp Pool. The North Leamex-Wolfcamp Pool was discovered by the Marathon Oil Company Stingray 10 State Well No. 1 located in Unit J of Section 10, Township 17 South, Range 33 East, NMPM, which was completed in the Wolfcamp formation on January 21, 2000. The top of the perforations is at 10,505 feet.
- (6) There is need for the creation of a new pool in Lea County, New Mexico for the production of gas from the Strawn formation, bearing the designation of West Pawnee-Strawn Gas Pool. The West Pawnee-Strawn Gas Pool was discovered by the Prize Operating Company South Lea Federal Well No. 1 located in Unit K of Section 17, Township 26 South, Range 36 East, NMPM, which was completed in the Strawn formation on June 15, 2000. The top of the perforations is at 13,024 feet.
- (7) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Wolfcamp formation, bearing the designation of South Pitchfork Ranch-Wolfcamp Pool. The South Pitchfork Ranch-Wolfcamp Pool was discovered by the EOG Resources Inc. Javalina 17 Federal Well No. 3 located in Unit L of Section 17, Township 25 South, Range 34 East, NMPM, which was completed in the Wolfcamp formation on December 1, 1999. The top of the perforations is at 13,704 feet.
- (8) There is need for the creation of a new pool in Lea County, New Mexico for the production of oil from the Drinkard formation, bearing the designation of Northeast Vacuum-Drinkard Pool. The Northeast Vacuum-Drinkard Pool was discovered by the Southwestern Energy Production Company Bimini 13 State Well No. 2 located in Unit L of Section 13, Township 17 South, Range 35 East, NMPM, which was completed in the Drinkard formation on September 9, 2000. The top of the perforations is at 6,977 feet.
- (9) There is need for the contraction of the vertical limits of the Lovington-Pennsylvanian Pool in Lea County, New Mexico to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the Lovington-Upper Pennsylvanian Pool.

- (10) There is need for the contraction of the vertical limits of the West Lovington-Pennsylvanian Pool in Lea County, New Mexico to include only the Cisco, Canyon and Strawn formations and the redesignation of the pool as the West Lovington-Upper Pennsylvanian Pool.
- (11) There is need for the contraction of the Weir-Drinkard Pool in Lea County, New Mexico to correct nomenclature.
- There is need for certain extensions to the Austin-Permo Upper Pennsylvanian (12)Pool, the South Bell Lake-Atoka Gas Pool, the Bilbrey-Atoka Gas Pool, the Blinebry Oil and Gas Pool, the Bootleg Ridge-Morrow Gas Pool, the South Corbin-Morrow Gas Pool, the DK-Abo Pool, the Southwest Diamondtail-Delaware Pool, the Draper Mill-Wolfcamp Gas Pool, the EK-Delaware Pool, the Southwest Eunice-San Andres Pool, the North Feather-Morrow Gas Pool, the East Gem-Delaware Pool, the Gem-Morrow Gas Pool, the East Gem-Morrow Gas Pool, the North Hardy-Strawn Pool, the North Hardy-Tubb-Drinkard Pool, the Hat Mesa-Delaware Pool, the Imperial-Tubb-Drinkard Pool, the Johnson Ranch-Wolfcamp Gas Pool, the West Lovington-Upper Pennsylvanian Pool, the West Lovington-Strawn Pool, the West Lovington-Upper San Andres Pool, the Lusk-Bone Spring Pool, the North Lusk-Strawn Pool, the Maljamar-Paddock Pool, the West Midway-Upper Pennsylvanian Pool, the Monument-Tubb Pool, the West Nadine-Tubb Pool, the West Ojo Chiso-Morrow Gas Pool, the South Pearl-Bone Spring Pool, the North Pearl-Morrow Gas Pool, the Quail Ridge-Morrow Gas Pool, the West Red Tank-Delaware Pool, the South Sand Dunes-Bone Spring Pool, the East Sand Dunes-Delaware Pool, the Shoe Bar-Atoka Gas Pool, the North Shoe Bar-Devonian Pool, the North Shoe Bar-Strawn Pool, the East Skaggs-Abo Pool, the Skaggs-Drinkard Pool, the North Teague-Lower Paddock-Blinebry Associated Pool, the Teas-Bone Spring Pool, the Teas-Delaware Pool, the Tonto-Atoka Gas Pool, the Townsend-Morrow Gas Pool, the North Vacuum-Atoka-Morrow Gas Pool, the Northeast Vacuum-Blinebry Pool, the Wantz-Abo Pool, the Warren-Tubb Gas Pool, the Weir-Drinkard Pool and the Wilson-Morrow Gas Pool, all in Lea County, New Mexico, and the Bluitt-San Andres Associated Pool in Roosevelt County, New Mexico.
- (13) The effective date of this order and all creations, contractions of vertical and horizontal limits, redesignations, and extensions included herein should be January 1, 2001.

#### IT IS FURTHER ORDERED THAT:

- (1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102, dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.
- (2) The effective date of this order and all creations, contractions of vertical and horizontal limits, redesignations, and extensions included herein shall be January 1, 2001.
- (3) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
