## BEFORE THE OIL CONSERVATION COMMISSION OF THE STATE OF NEW MEXICO

IN THE MATTER OF THE HEARING CALLED BY THE OIL CONSERVATION COMMISSION OF NEW MEXICO FOR THE PURPOSE OF CONSIDERING:

THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING, CONTRACTING, AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on January 14, 1970, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 20th day of January, 1970, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new oil pool in Eddy County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation of Big Eddy-Bone Spring Pool. Said Big Eddy-Bone Spring Pool was discovered by the Pennzoil United, Inc. Big Eddy Unit Well No. 12, located in Unit D of Section 21, Township 20 South, Range 31 East, NMPM. It was completed in the Bone Spring formation on August 17, 1969. The top of the perforations is at 8565 feet.
- (3) That there is need for the creation of a new oil pool in Lea County, New Mexico, for the production of oil from the

Drinkard formation, said pool to bear the designation of Cline-Drinkard Pool. Said Cline-Drinkard Pool was discovered by the Imperial-American Management Company Lineberry Well No. 1, located in Unit I of Section 11, Township 23 South, Range 37 East, NMPM. It was completed in the Drinkard formation on February 20, 1969. The top of the perforations is at 6421 feet.

- (4) That there is need for the creation of a new gas pool in Lea County, New Mexico, for the production of gas from the Blinebry formation, said pool to bear the designation of House-Blinebry Gas Pool. Said House-Blinebry Gas Pool was discovered by the Damson Exploration Corporation L. D. Jones Well No. 1, located in Unit H of Section 1, Township 20 South, Range 38 East, NMPM. It was completed in the Blinebry formation on March 1, 1969. The top of the perforations is at 6070 feet.
- (5) That there is need for the contraction of the Bough Permo-Pennsylvanian Pool in Lea County, New Mexico, by the deletion of certain acreage in order that said acreage may be placed in the Vada-Pennsylvanian Pool.
- (6) That there is need for certain extensions to the Sulimar-Queen Pool in Chaves County, New Mexico, the Double L-Queen Pool in Chaves and Lea Counties, New Mexico, the Vada-Pennsylvanian Pool in Lea and Roosevelt Counties, New Mexico, the Bagley-Pennsylvanian Pool, the Baum-Upper Pennsylvanian Pool, the South Corbin-Morrow Gas Pool, the Justis-Blinebry Pool, the West Sawyer-San Andres Pool, and the East Weir-Blinebry Pool, all in Lea County, New Mexico.

#### IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as an oil pool for Bone Spring production, is hereby created and designated as the Big Eddy-Bone Spring Pool, consisting of the following-described area:

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for Drinkard production, is hereby created and

designated as the Cline-Drinkard Pool, consisting of the following-described area:

(c) That a new pool in Lea County, New Mexico, classified as a gas pool for Blinebry production, is hereby created and designated as the House-Blinebry Gas Pool, consisting of the following-described area:

### TOWNSHIP 20 SOUTH, RANGE 38 EAST, NMPM Section 1: NE/4

(d) That the Bough Permo-Pennsylvanian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby contracted by the deletion of the following-described area:

(e) That the Vada-Pennsylvanian Pool in Lea and Roosevelt Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 8 SOUTH, RANGE 35 EAST, NMPM Section 36: W/2

(i) That the Double L-Queen Pool in Chaves and Lea Counties, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

(m) That the East Weir-Blinebry Pool in Lea County, New Mexico, as heretofore classified, defined, and described, is hereby extended to include therein:

TOWNSHIP 20 SOUTH, RANGE 37 EAST, NMPM Section 11: SE/4

#### IT IS FURTHER ORDERED:

- (1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Forms C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.
- (2) That the effective date of this order and all creations and extensions included herein shall be February 1, 1970.
