Operator arrived on location to a failure on the threads of the nipple just off of the 6H separator. Failure released approx. 17.8 bbl of produced water inside of the lined, secondary containment. As a vac truck and power wash crew was dispatched to wash/drain the separator for repairs, they also washed the containment/equipment and recovered all of the standing fluid inside of the containment. A 48 hour notice will be sent out prior to a formal liner inspection.
