Devon Energy Production Company (Devon) has contracted Talon/LPE (Talon) to perform soil assessment and remediation services at the above referenced location. The results of our site assessment and remediation activities are presented herein.

Site Information

Burton Flat Deep Unit #061H is located approximately seven (7) miles northeast of Carlsbad, New Mexico. The legal location for this release is Unit Letter L, Section 02, Township 21 South and Range 27 East in Eddy County, New Mexico. More specifically the latitude and longitude for the release are 32.507653 North and -104.168614 West. A site plan is presented in Appendix I.

According to the soil survey provided by the United States Department of Agriculture Natural Resources Conservation Service, the soil in this area is made up of Gypsum land-Reeves complex, 0 to 3 percent slopes, eroded. See Appendix II for referenced soil data. Per the New Mexico Bureau of Geology and Mineral Resources, the local surface and shallow geology is Holocene to middle Pleistocene in age and is comprised of eolian deposits of sandy and clay loam underlain by gypsiferous material. Drainage courses in this area are typically dry.

The New Mexico Office of the State Engineer Database indicates the nearest reported depth to groundwater is 14-feet below ground surface (BGS). See Appendix II for the referenced groundwater data.

Site Characterization

Incident Description

On May 1, 2020, 7 barrels (bbls) of produced water leaked from a 1-inch nipple onto the pad area near the wellhead. The release remained entirely on location. The initial C-141 is attached in Appendix III. A site map illustrating the affected area is presented in Appendix I.

Site Assessment

On July 9, 2020, Talon mobilized personnel to begin the site assessment and soil sampling activities for the construction of a work plan. Grab soil samples were collected within and around the impacted area utilizing a hand auger. Excavation depths and subsequent confirmation sample locations were selected based on this data. Results from our sampling events are presented in the following data table. Complete laboratory reports can be found in Appendix V.

Remedial Actions

- The impacted area in the vicinity of sample points S-2 and S-7 was excavated to a total depth of 4.0-feet BGS.
- The areas near sample points S-3 and S-8 were excavated to 3.0-feet BGS.
- The impacted soil in the vicinity of sample location S-6 was removed to a depth of 4.5-feet BGS.
- The impacted area surrounding sample point S-5 was removed to a depth of 3.5-feet, and in the vicinity of S-4 the excavation was completed at 2.5-feet deep.
- Confirmation samples were obtained from the sidewalls and bottoms of the excavated areas to verify that all contaminants above NMOCD closure criteria had been removed.
- A confirmation sample location map is provided in Appendix I and photographic documentation of remediation activities is also appended (Appendix IV).
- All the excavated material was hauled to Lea Land, LLC, a NMOCD approved solid waste disposal facility.
- The excavated area was backfilled with new caliche, machine compacted and contoured to match the surrounding location.
- The Final C-141 formally documenting the remedial actions is attached in Appendix III.
