Please explain reason for why this event was beyond this operator's control	MarkWest Plat in Culberson Co, TX stopped taking gas in the middle of the night. It was so severe that the issue actually pushed itself into the Eddy county gathering system. We ended up shutting in the Foxx wells, Da Vinci wells, Scoter wells, and Marquardt well to prevent flaring. Markwest is back online now
Steps taken to limit the duration and magnitude of vent or flare	As noted Cimarex shut in wells not only in this facility but others to mitigate flaring impact due to shut in. Cimarex was notified of event per force majeure notice on 9/30, but downstream operator was in Texas that spilled over into New Mexico.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	As noted Cimarex will take steps to curtail production and shut in wells to prevent flaring as evidence by this event.
