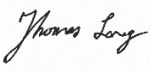
Cause of Release: On January 29, 2022, Enterprise had a release condensate from failed gasket associated Blanco Storage Tank Battery facility pump. No washes or residents were affected. No fire occurred. No emergency services responded. All liquids were released inside a lined secondary containment structure. Approximately six barrels of condensate was released and approximately six barrels of condensate was recovered. Enterprise has cleaned the secondary containment and will schedule an inspection time the NMOCD District III. A "Final C-141" and supporting documentation will be submitted after completion of inspection.
