**Cause of Release:** On March 2, 2022, Enterprise had a release of natural gas and condensate from the Lateral 2C-6. The meter tube was isolated, depressurized, locked and tagged out. No residents were affected. No washes were affected. No emergency services responded. The release flowed down a small hill approximately 200 feet. An area of approximately 200 feet long by one foot wide was affected by the release fluids. A third party corrective action report will be submitted with the "Final C-141."


