Please explain reason for why this event was beyond this operator's control	There was a malfunction at the facility with controlling the vapor pressure which then led to the VRU shutting down due to low suction pressure and high oil temp, resulting in a venting emission event.
Steps taken to limit the duration and magnitude of vent or flare	VRU were able to run intermittently during the duration of the event, along with ROA system choking back wells to reduce production which then reduces the amount of gas vented. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
