Estimated spilled is 42.24 bbls of oil, produced water, and rain water in the lined containment. Fluids did not breach the containment or reach the pad or go offsite. Wells were shut in to shut down the LACT to stop tank from overflowing. Vacuum trucks dispatched. Recovered volumes not available at this submission
