Steps taken to limit the duration and magnitude of vent or flare	Vented approx 4 hours to purge system to get below Targa set points to avoid shut in situation. Once below setpoint was able to run VRU and stop venting from tanks.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. Reportable quantities, process knowledge, excel spreadsheet, metered volumes, and gas analysis were used in the calculations.
