Due to rain at the time of discovery, a precise estimate of the volume of firewater that overflowed was not available, best estimate provided was 200bbls was released to ground. Water released to the ground was sampled and the results showed chloride and total dissolved solid concentrations below the 20.6.2.3103 NMAC standards.
