For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control	True
Please explain reason for why this event was beyond this operator's control	Faulty LEL sensors on compressors caused the compressors to shutdown multiple times resulting in flaring. The compressor station also experienced an emergency shutdown while starting unit back up which resulted in additional flaring. Compressor starters, pre-lube oil pumps, and solenoids needed repair.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Maintenance crews were called out to repair starters, pre-lube oil pumps, and solenoids. Once repairs were made the compressors were restarted and flaring ended.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. Maintenance crews were brought out as soon as possible to make the needed repairs.
