An environmental consultant was retained to investigate and assess the site. Based on the assessment of the site, scattered areas of minimal chloride impaction were discovered, which individually would not meet a threshold for reportability based on the size and volume of soil. However, if the areas become contiguous then the volume could possibly be considered for reportable. In an abundance of caution, a C-141 is being submitted for the site and remediation will be completed to current Spill Rule (NMAC 19.15.29) requirements.
