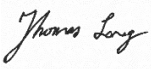
Cause of Release: On October 10, 2022, Enterprise had a release of natural gas from the Lateral 2B-24. The pipeline was isolated, depressurized, locked and tagged out. Approximately two barrels of release liquids were observed on the ground surface. No emergency services responded. No fire nor injuries occurred. The release occurred in a small ephemeral wash (blue line on a Topo). Remediation and repairs are in the scheduling process. A third party corrective action report will be submitted with the "Final C-141."
