1. Reason why this event was beyond Operator's control:

This emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction or complete shut-in of a gas pipeline by a third-party pipeline operator, which impacted Oxy's ability to send gas to a third-party gas pipeline. This interruption, restriction, or complete shut-in of the gas pipeline by a third-party pipeline operator is downstream of Oxy's custody transfer point and out of Oxy's control to avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, ETC suddenly and unexpectedly curtailed their gas intake from Oxy due to issues on their end, during a sale gas route transition from Enterprise to ETC, which then triggered a flaring event to occur. As soon as flaring began, the Corral 2 South compressor station's well optimizer very slowly adjusted injection rates and shut-in several wells to cease flaring.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route all stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, as the part of the overall process or steps to take to limit duration and magnitude of flaring. Oxy personnel are in the field 24/7 and can physically see when we are flaring which in turn are communicated to additional Oxy field personnel. Internal OXY procedures ensure that upon gas compressor unit and/or multiple unit shutdown, increased sensor line pressure alarms, etc., field production technician personnel are promptly notified, and are instructed to assess the issue as soon as possible to take prompt corrective action and minimize emissions. Oxy production technicians must assess whether the issue or circumstance is due to damage and repair is needed, or whether there are other reasons for its cause. In this case, ETC suddenly and unexpectedly curtailed their gas intake from Oxy due to issues on their end, during a sale gas route transition from Enterprise to ETC, which then triggered a flaring event to occur. As soon as flaring began, the Corral 2 South compressor station's well optimizer very slowly adjusted injection rates and shut-in several wells to cease flaring.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in its corrective actions to eliminate the cause and potential reoccurrence of an ETC sales gas service system pipeline constraint/restriction or shut in, as this control issue is downstream of Oxy's custody

transfer point and out of Oxy's control to avoid or prevent from happening or reoccurring. Energy Transfer's downstream facility issues will reoccur from time to time and may trigger a spike in their gas line pressure, which in turn, directly impacts Oxy's ability to send gas to them and prompts Oxy field personnel to engage in secondary offloading procedures, when possible. When Energy Transfer's downstream plant and/or its associating downstream facilities has issues or greatly struggles to handle the volume of gas being sent to them by Oxy, ETC then restricts Oxy's ability to send gas, which then prompts Oxy to route its stranded gas not pushed into their sales gas pipeline, to flare. OXY makes every effort to control and minimize emissions as much as possible. The limited reactive actions that Oxy can do in this circumstance is to ensure that the facility's well optimizer adjusts injection rates and shuts-in wells to cease flaring.
