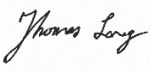
Cause of Release: On May 17, 2023, Enterprise had a release of natural gas and natural gas liquids from the Trunk 10A pipeline. The pipeline was isolated, depressurized, locked and tagged out. No fire nor injuries occurred. Minimal liquids were observed on the ground surface. Repairs and remediation began on June 9, 2023, and Enterprise determined the release reportable per NMOCD regulation, due to the volume of impacted subsurface soil on June 12, 2023. A third party corrective action report will be submitted with the "Final C-141."
