Flow to WDW-3 was blocked in and injection at WDW-3 halted. The concrete vault has concrete walls and a dirt bottom. All effluent remained within the confines of this concrete vault. Treated wastewater found in the vault was removed via vacuum truck and transported back to HF Sinclair Navajo Refining for treatment. Vacuum trucks made periodic rounds to vacuum water out of the vault until final repairs could be made on June 26, 2023. |
