For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control	True	
Please explain reason for why this event was beyond this operator's control	The emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction or complete shut-in of a gas pipeline by a third-party pipeline compressor station operator, which impacted Oxy's ability to send gas to them. This interruption, restriction or complete shut-in of the gas pipeline by a third-party pipeline compression station operator is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, ETC, third party owned and operated downstream pipeline operator, shut in their gas service to Oxy twice, due to planned maintenance of their equipment on their end, which in turn caused high line pressure to occur, once mid-afternoon and then again in the late afternoon, which triggered two instances of flaring to occur. The combined duration of both flaring events totaled 180 minutes.	
	It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, ETC, third party owned and operated downstream pipeline operator, shut in their gas service to Oxy twice, due to planned	

St	teps taken to limit the duration and magnitude of vent or flare	maintenance of their equipment on their end, which in turn caused high line pressure to occur, once mid-afternoon and then again in the late afternoon, which triggered two instances of flaring to occur. The combined duration of both flaring events totaled 180 minutes. During each brief instance of flaring, field personnel engaged in Oxy's third party pipeline operation curtailment reactive stratagems and assisted with ensuring field area's mitigation optimizers cut injection rates to wells in the field to reduce injection and sales gas across the area. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.
Co	orrective actions taken to eliminate the cause and reoccurrence of vent or flare	Oxy is unable to take any corrective actions to eliminate this cause and potential reoccurrence of this circumstance of flaring as this emissions event was caused by a third-party pipeline operator's downstream facility maintenance activity, which is beyond Oxy's control to prevent or control from happening. Shut ins or restrictions of gas intake by a third-party pipeline operator is downstream of Oxy's custody transfer point. While this event was out of Oxy's control to prevent from happening, Oxy made every effort to minimize emissions while ETC was having downstream maintenance activity issues.
