The BGT is being evaluated and the cause of release is currently under investigation. Upon discovery, stained soils beneath the BGT were excavated until bedrock was encountered. The impacted soils were hauled to Envirotech landfill in Bloomfield, NM for disposal. A 5-point composite confirmation soil sample was collected at the base of the excavation and results indicate elevated levels of Total BTEX and TPH. Remediation options are currently being evaluated.
