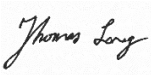
**Cause of Release:** On November 6, 2023, Enterprise had a release of natural gas and natural gas liquids from the Huerfano #188 pipeline. The pipeline was isolated, depressurized, locked and tagged out. No fire nor injuries occurred. No washes/waterways were affected. No liquids were observed on the ground surface. Repairs and remediation began on November 13, 2023, at which time Enterprise determined the release reportable per NMOCD regulation by the volume of impacted subsurface soil. A third party corrective action report will be submitted with the "Final C-141."
