Steps taken to limit the duration and magnitude of vent or flare	Decreased inlet gas flowrates, increased methanol injection into fuel gas system to clear hydrates, and brought compressors back online when the fuel system was cleared. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
