Please explain reason for why this event was beyond this operator's control	Event lasted until 01:39AM on 11/27/23. Two pumps on dehy system, both began to fail simultaneously causing overpressure of blanket gas on storage tanks.
Steps taken to limit the duration and magnitude of vent or flare	One dehy pump was repaired and filters replaced in order to bring down pressures on system. Second pump needs replacement, which will be done as soon as possible. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented.
