1. Reason why this event was beyond Operator's control:

The emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable interruption, restriction or complete shut-in of a gas pipeline by a third-party pipeline operator, which impacted Oxy's ability to send gas to a third-party gas pipeline. This interruption, restriction or complete shut-in of the gas pipeline by a third-party pipeline operator is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid or prevent from happening and did not stem from any of Oxy's upstream facility activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. In this case, Red Tank Boo 26 compressor station, third party owned and operated by USA Compression, had an emergency shutdown due to losing their communication tower, which in turn, resulted in a sudden and unexpected restriction of gas flow intake by them, which caused Oxy's Red Tank 27-28 CTB to pressure up automatically and trigger a flaring event to occur. This event could not have been foreseen, avoided or prevented from happening as this flaring event occurred with no advance notice or warning to Oxy and its field personnel from USA Compression personnel. Red Tank 26 Boo compressor station is the first stopping point, where OXY sends its sales gas from its facility, before it is pushed further down the pipeline for further processing at Mark West, a downstream gathering system facility, which is downstream of Oxy's control.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. In this case, Red Tank Boo 26 compressor station, third party owned and operated by USA Compression, had an emergency shutdown due to losing their communication tower, which in turn, resulted in a sudden and unexpected restriction of gas flow intake by them, which caused Oxy's Red Tank 27-28 CTB to pressure up automatically and trigger a flaring event to occur. The Oxy production techs, who were on-site, continually kept in touch with additional Oxy field personnel to make adjustments to injection rate changes, to minimize emissions during USA Compressions' attempts to resolve their equipment issues. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy cannot take any corrective actions to eliminate the cause and potential reoccurrence of a third-party owned and operated compressor station's sudden and unexpected gas flow intake restriction or shut-in, as this control issue is downstream of Oxy's custody transfer point and out of Oxy's control to foresee, avoid, prevent from happening or reoccur. Third-party downstream compression station owner operators may have equipment issues, which will reoccur from time to time, which in turn, directly impacts Oxy's ability to send its sales gas to them, and potentially triggering a flaring event. OXY makes every effort to control and minimize emissions as much as possible. The only actions that Oxy can take and handle that is within its control, is to continually communicate with USA Compression personnel, who operate the Red Tank Boo 26 Compressor Station, when possible, during these types of circumstances.
