Please note: I was looking through the records for this API and came across the following open release case numbers [2RP-3805](#) which happened back on 7/24/16 all that we have in our records that was submitted for this release is the Initial C-141 form and photos that Devon took of the release. The Initial C-141 form for this release is attached above for Devon to reference.

The second oldest release on file is case number [2RP-1771](#) which happened back on 7/25/13 all that we have on record for this release is an Initial C-141, I have attached it above.

The last oldest release at this site we have on file has a case number of [2RP-6](#) and appears to have occurred back around 10/2007 not much information on this one. It appears in the records that an attempt was made to close this out but it was not followed through with according to what I could find. I attached above the last item we have on file for this release. It mentions a final C-141 but we do not have one for this release.

Please follow up on these older releases and get back to OCD with a plan of action or some forward moving efforts on them by no later than 1/5/2018.
