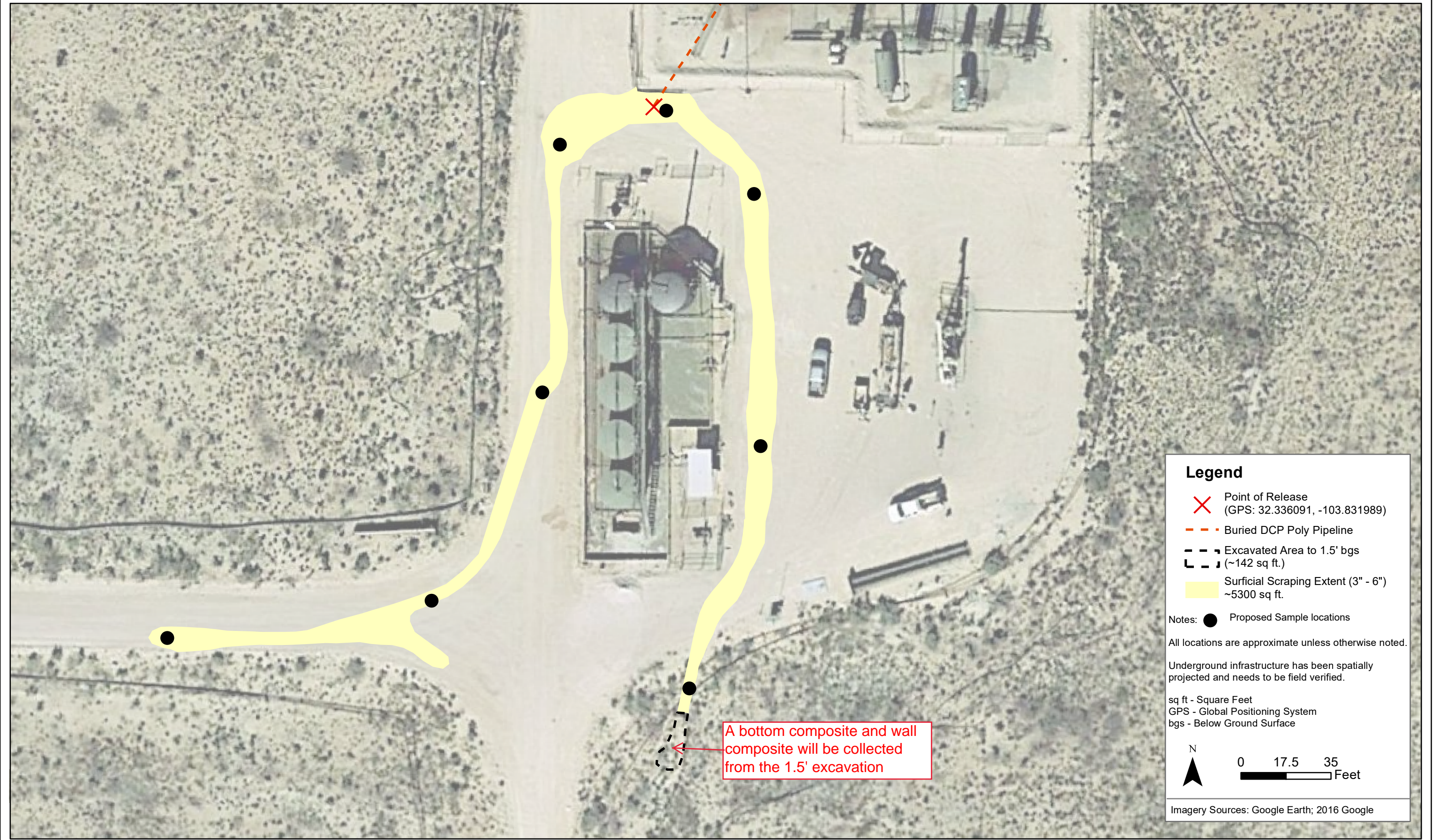
Ms. Venegas and Mr. Bratcher,

On behalf of DCP Midstream, Tasman proposes the following alternative sampling plan for the James Ranch Pipeline Release Site. Tasman proposes the collection of discrete soil samples from the base of the excavated area at increments not to exceed every one hundred linear feet for confirmation analysis of TPH, BTEX, and chloride in areas where there is a depth of six inches or less below ground surface (BGS). In the areas exceeding six inches BGS, Tasman proposes the collection of composite method soil samples from the base and sidewalls of the excavated area representing no more than 200 square feet for confirmation analysis of TPH, BTEX, and chloride. Please find the attached Figure 1 – Excavation Overview Figure for reference of excavated areas at the Release Site.

9. FEMA National Flood map review.
10. Signed and dated C-141 (Pages 3-5)
