The cause of the release is due to floating over oil going into the open water leg valve on the gun barrel tank, when the valve was opened, water was released from the top of the water leg. The release was reported as approximately 14 bbls of produced water, of which 12 bbls were recovered. The release footprint was limited to the lined containment area. A wash crew was immediately sent to respond with steamer, water buffalo, and vacuum truck.
