Steps taken to limit the duration and magnitude of vent or flare	Hydrate was discovered in the kimray scrubber dump valve on the fuel skid. After line was isolated the vru was able to bring the blanket gas pressure down and stop venting. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented.
